

## DECLARATION ON DATA TRANSFER

hereby acknowledge that the UniCredit Bank Hungary Zrt. (hereinafter: Bank) expressly drew my attention before the concluding of the financial services / investment services agreement (hereinafter: Agreement) to the point 6.10 / A. sub-paragraph of the Chapter I of the General Terms and Conditions of the Bank regulated the "Bank secrecy, handling of personal data, provision of data to third parties". In connection with the above I take note of the detailed information of the Bank in this regard as follows.

### Information of the bank

Pursuant to point 6.10 / A. sub-paragraph of the General Terms and Conditions of the Bank, and on the basis of section 164/B. of Act CCXXXVII of 2013 on credit institutions and financial undertakings, the Bank and UniCredit Leasing Hungary Zrt. (hereinafter UniCredit Leasing) operating under the influence of the Bank are entitled, in connection with the performance of their activities, to the extent necessary for the provision of their services:

- (a) to know the personal data of each other's customer as well as' banking, securities, payment or insurance secrets and business secrets of each other's' customers, as well as
- (b) to forward them to each other in order to provide access to specific services, and
- (c) to use the data received to contact each other's' customers; and
- (d) to manage the data received from each other for the duration of the establishment and existence of the customer relationship.

The Bank, exercising its right detailed above, may transfer data to UniCredit Leasing in respect of

- any set of data permitted by law in case of corporate clients,
- limited data set detailed in „Data controlling guidelines” that is annex No. 2 of General Terms and Conditions in case of natural person clients. (Related to consumer clients: Client's name, Name of the client's mother, Client's birth name, Client's birth date, e-mail address, Permanent address, Correspondence address, Phone number.  
related to non-consumer natural person clients: Client's name, First 8 number of tax number (registration number), e-mail address, Registered office address, Correspondence address, Phone number).

The data provided by the Bank may be used by UniCredit Leasing for the purpose detailed above within 60 days of receipt.

In case of natural person clients, UniCredit Leasing will delete these data from its records after this period.

Both before and after the conclusion of the agreement you may any time prohibit the transfer of the data to UniCredit Leasing with your declaration addressed to the Bank with respect to the future.

You can make a declaration on the above mentioned topic either within the current declaration or also later by giving the necessary data for identification (in case of natural persons: Name, Place and date of birth, Mother's name; in case of companies: company name, representative name, tax number) in any of our branches personally or giving the subject of the protest "Objection to the transfer of the data to UniCredit Leasing Hungary Zrt." electronically with a request sent to the tiltakozonyilatkozat@unicreditgroup.hu e-mail address.

Following its prohibition order, the Bank will no longer transfer its data to UniCredit Leasing.

Please note that the General Terms and Conditions is an inseparable Annex of the agreement to be concluded with you and is available any time in our branch offices and on our website at [https://www.unicreditbank.hu/hu/rolunk/hasznos\\_informaciok/eqyeb\\_informaciok/uzletszabalyzatok.htm](https://www.unicreditbank.hu/hu/rolunk/hasznos_informaciok/eqyeb_informaciok/uzletszabalyzatok.htm) in the future as well.

Pursuant to paragraph (5) of point I. 6.10/A of General Terms and Conditions of Bank, I hereby prohibit the data transfer to UniCredit Leasing Hungary Zrt. operating under the influence of the Bank. □
